6.1 Superintendent Report

- BES Phase II approx 6 weeks behind schedule; move in date around May 17th. Ken Riordon will arrange a walk-through for the trustees The move is planned close to the end of the school year in order to expedite the tear-down of the old building and prepare a field for the students as soon as possible
- Kindergarten Open House dates have been set
- Alpenglow is seeing increased interest and expect enrollments to rise for next school year
- Meetings taking place to plan another Google Summit for the start of 2019-2020
- Preliminary meeting with the Town of Canmore regarding LGMS land development
- Developing a Canadian Rockies Ski Academy due to interest from numerous international agents. Superintendent reviewed detailed brochure being prepared to go to agents. Substantial revenue will be realized from this program
- International Student recruiting will be spread between several CRPS staff members. Thirty-eight students have registered for next school year already with the distribution coming from a mix of many countries. Incentives being developed to promote homestay families.
- Learning calendar for 2019-2020 in the development stage. Currently proposing a one-year calendar for now due to possible changes within Alberta Education that may affect the calendar. Final version will be brought forward potentially in March.
- OLC continues to do amazing work. As of today 80 students

have been registered for summer CALM. Expect to fill the sessions to capacity once again. Have added an extra staff member to the OLC in order to accommodate requests from some of the elementary schools in the division for their students to take part in outdoor experiential courses

 The hope is to eventually generate enough revenue through the OLC to eliminate all fees for our own CRPS students for these outdoor learning courses

6.1.1 Intellimedia - School Engage

- CRPS has contracted Intellimedia to assist with the digitization of documents such as registrations, forms and all other pertinent documentation etc.
- This is a directive from Alberta Education which states all school divisions in Alberta must be compliant by the year 2020.
- CRPS is partnering with Chinook's Edge School Division to provide a significant cost savings for signing on with Intellimedia that will be beneficial for training and implementation
