Major Duties & Responsibilities

The Coordinator: Education Service Agreement will work closely with the other members of the senior administration team and School teams to achieve all aspects of the Education Service Agreement between Stoney Education Authority and Canadian Rockies School Division and to fulfill all duties as assigned by the Superintendent. The Coordinator: Education Service Agreement will be responsible for:

- 1. Organizing all meetings as outlined in the ESA, including but not limited to:
 - a. Programming Meetings
 - b. Student Transfers
 - c. Cultural Programming
 - d. Annual Review
- 2. Collecting and collating data as outlined in the ESA
- 3. Tracking registration of students covered by the ESA
- 4. Supporting program and service delivery for students covered by the ESA
- 5. Supporting the Director of Learning Services in addressing Inclusive Education needs of students covered by the ESA
- 6. Supporting and implementing learning opportunities that address cultural awareness and language development for students covered by the ESA
- 7. Supporting the Elders Committee, including but not limited to:
 - a. Supporting teachers in accessing elders to support learning opportunities for students
 - b. Tracking the times elders are utilized throughout the division
 - c. Ensuring Elders are appropriately paid and supported in their work throughout the division
 - d. Assisting Elders in supporting student attendance
 - e. Arranging meetings between senior administration and Elders as requested by senior administration

- 8. Supporting Indigenous Land-Based Learning opportunities for students covered by the ESA
- 9. Supporting the Director of Learning Services and school staff to ensure students covered by the ESA have appropriate supports
- 10. Supporting the Director of Learning Services and school staffs to ensure students covered by the ESA have access to resources to support their well being, including but not limited to:
 - a. Food programs
 - b. Weather appropriate clothing
 - c. Counseling
 - d. Elder support
- 11. Supporting collaboration between Stoney Education Authority and Canadian Rockies School Division teachers to design and implement learning opportunities for students across the two divisions.
